#### <u>Warli Art</u>

Warli's is a tribal community living in Dangs and Maharashtra. The Warli's, live a simple life. Most of them are farmers and hunters. The unique aspect of the Warli community is their art. The art is usually used to adorn and decorate houses.





The Warli paintings use minimal materials, simple shapes yet they express their thoughts elegantly. The lifestyle of the warli's is simple and connected to nature. They believe nature will provide them with everything when they need it. The mindset to hoard and save for the future is not prevalent.

# <u>Pithora Art</u>

A Pithora is a living testament of an ever changing ethos exemplifying highly



enriched Folk Art Culture of Gujarat. It was originated from an ancient ritualistic tradition of mural paintings initiated within tribal beliefs and customs in the region of Chhota Udaipur and Vadodara district. The Pithora contains elements drawn from oral history, tribal legends and fantasy, stunning horses, birds and animals. hills and

topography. The Pithora murals still continues to hold its place of pride and high ritual in tribal society today.

Shri Desing Rathwa and Shri Haribhai Rathwa are self taught born Pithora artists from village TEJGADH in Chhota Udaipur district, Gujarat. They are demonstrating the Pithora art in various institutes and colleges to



promote the Pithora art. They are associated with the BHAASHA NGO in Tejgadh, working for the Panchmahal tribes since 2004 and doing the Pithora work. Their works are displayed at various national exhibitions, art and craft fairs.

#### <u>Tie – Dye Work</u>

Tie-dye is a process of tying and dyeing а piece of fabric or cloth which is made from knit or woven fabric, usually cotton; typically using bright colors. It is a modern version of traditional dveing methods used in many cultures throughout the world.



Tie-dyeing is accomplished by folding the material into a pattern, and binding it with string or rubber bands. Dye is then applied to only parts of the material. The ties prevent the entire material from being dyed. Designs are formed by applying different colors of dyes to different sections of the wet fabric. Once complete, the material is rinsed, and the dye is set.






#### Adventure cum Nature Study Program

Bakore is named after the mythological character of Bakasur. Nearby to Bakore is the famous Kaleshwari archeological site which you will be visiting. It is a rolling countryside with Arravalli Hills all around and once was a Tiger country. Today, if we even see the pugmarks of a Leopard, it will be our good luck. The place is also known to have a number of seasonal wetlands and nearby there is a waterfall where a number of picnickers go.



The campsite is located in bakor village in



north gujarat very close to the rajasthan border. It is about 140 km from ahmadabad.

Activities: The two-day camp involves trekking, knots learning, bird watching, Tree education, cross country trek, flora and fauna introduction, Plantation, Obstacle, Heritage site visit.

Things to Carry: Pull over, sweater, 2 pairs of clothes, water bottle, toilet kit, towel, shoes-

shocks, cap, torch, bird book, binocular, personal medicine, mosquito repellent cream, Note pad & pen. Camera and its kit at own risk.

# <u>Mata Ni Pachedi</u>

The art form is also known as 'Kalamkari of Gujarat' due to its resemblance to the Kalamkari of South India, which is the same method of painting, namely using a pen (kalam) made out of bamboo. Mata ni pachedi which basically means "behind the idol of the Goddess" is a cloth enshrined with painting narratives of Goddess Durga in her various incarnations.



The pachedis are essentially an expression of the divine cosmic energy of the mother goddess and the unified manifestation of the creative and the destructive principles in her person. Its believed that the nomadic Devipujak community (Vaghari) of Gujarat belonged to a lower caste and were labeled as 'untouchables'; due to which they were barred from entering temples and other religious places. To overcome this repugnant restrictive practice they found an ingenious solution and created their own shrines of worship. They painted illustrations of the Goddess on a piece of cloth known as Mata ni pachedi, hung it behind the temple and directed their worship at the paintings of the Goddess. At the center of each pachedi was the main picture of the Goddess surrounded with images from the legends of her life.

This way a beautiful folk-art form Mata ni pachedi came into existence!

### **Block Printing**

Block printing is one of the oldest techniques used to create imprints and marks on fabric to create splendid fabrics. Block printed fabrics from India have been and continue to be the country's most popular exports to the world. It is a technique which



allows you to reproduce an image on paper, textile, or fabric.

**Shri Jayantibhai Chitara** is a renowned artist of the Kalamkari and Block Printing form and has many exhibitions to his credit. He has experience of 35-40 years in Block Printing. He has been conducting workshops in NID,



NIFT, MSU since years and also awarded with National Merit Certificate.

During these workshops students will develop their skills in block printing and also gain experience by learning and working alongside skilled craftsperson. It is very interesting to see how the prints are handmade with small wooden blocks, usually with different colors extracted from nature as well as Pigment dye colour with Binder.

## Sun Temple, Modhera

The Sun Temple is a Hindu temple dedicated to the solar deity Surya located at Modhera village of Mehsana district, Gujarat, India. It is situated on the bank of the river Pushpavati. It was built in 1026-27 AD



during the reign of Bhima I of the Chaulukya dynasty. No worship is offered now and is protected monument maintained by Archaeological Survey of India. The temple complex has three components: Gudhamandapa, the shrine hall; Sabhamandapa, the assembly hall and Kunda, the reservoir. The halls have intricately carved exterior and pillars. The reservoir has steps to reach bottom and numerous small shrines.



#### Rani ki Vav, Patan

Vav(Queen's step Rani ki well) is an intricately constructed stepwell situated in the town of Patan in Gujarat, India. It is located on the banks of Saraswati River. Rani ki Vav was built as a memorial to an 11th century AD kina Bhimdey I. It was added to the list of UNESCO's World



Heritage Sites on 22 June 2014. Stepwells are a distinctive form of subterranean water resource and storage systems on the Indian subcontinent, and have been constructed since the third millennium BC. It has seven levels of stairs and holds more than 500 principal sculptures.

Rani ki Vav was constructed during the rule of the Chaulukya dynasty. It is generally assumed that it was built in the memory of Bhima I (r. c. 1022–1064) by his widowed queen Udayamati and probably completed by Udayamati and Karna after his death. A reference to Udayamati building the monument is in Prabandha Chintamani, composed by the Jain monk Merunga Suri in 1304 AD.

#### GANHDI ASHRAM

The Sabarmati Ashram (also known as Harijan Ashram) was home to Mohandas Gandhi from 1917 until 1930 and served as one of the main



centres of the Indian freedom struggle. Originally it was called the Satyagraha Ashram, reflecting the movement toward passive resistance launched by the Mahatma. It was also from here on 12 March 1930 that Gandhi launched the famous Dandi March 241 miles from Ashram (with 78 companions) in protest of the British Salt Law, which taxed Indian salt in an effort to promote sales of British salt in India

The Ashram now has a Museum also. This had originally been located in 'Hridaya Kunj', Gandhi's own cottage in the Ashram. Then in 1963, having been designed by the architect Charles Correa, the Museum was built. The Sangrahalaya was then re-located into the well-designed and well-furnished Museum building and was inaugurated by Jawaharlal Nehru, Prime Minister of India on 10 May 1963. Memorial activities could then continue.



## Vegetable Dye Painting



The art and technology of permanently coloring cloth with dye originated in India and spread throughout the world via trade. As early as 3000 BCE, Indian dyers were producing solid colored and patterned cloth using vegetable dyes and mordents. Some of the

cloth was patterned through printing, a technique that uses very simple tools.

Graphical, vivid, multicolored animated images of gods and goddesses, devotees and followers, flora and fauna, splurge the magnificence of narrative art of Mata-ni-Pachedi.

#### Japanese Fan Making Workshop

Japanese fans are made of paper on a bamboo frame, usually with a design painted on them. In addition to folding fans the nonbending fans are popular and common place. The fan is primarily used for fanning oneself in hot weather.The Mai Ogi (or Japanese dancing fan) has ten sticks and a thick paper mount showing



the family crest, and Japanese painters made a large variety of designs and patterns. The slats, of ivory, bone, mica, mother of pearl, sandalwood, or tortoise shell, were carved and covered with paper or fabric. Folding fans have "montures" which are the sticks and guards, and the leaves were usually painted by craftsmen. Social significance was attached to the fan in the Far East as well, and the management of the fan became a highly regarded feminine art. Fans were even used as a weapon – called the iron fan, or tessen in Japanese.

Mr. Ujal Shah holds a Ph.degree in Japanese Art from Kansai University, Japan. He won five best international awards in miniature Japanese kites in 2008 and 2001 in Indonesia and 2010, 2011 in Malaysia and Hong-kong.

# <u>Madhubani Art</u>

Madhubani – Mithila Painting (also called Madhubani art or Mithila painting) is practiced in the Mithila region of India and Nepal. Painting is done with fingers, twigs,

brushes, nib-pens, and matchsticks, using natural dyes and pigments, and is characterised by eye-catching geometrical patterns. There is ritual content for particular occasions, such as birth or marriage, and festivals, such as Holi, Surya

Shasti, Kali Puja, Upanayana, Durga Puja.

# POLICY FOR AUDIT COURSE

#### 1. RULES & REGULATIONS

- All weekends are earmarked for Audit Course and students should be prepared to attend the same at short notice as the scheduling depends heavily on the availability and time of the resource persons.
- A student attending an audit course is required to participate in all the audit programs including compulsory program during the year.
- Resource people for any activities are subject to change.
- Date & Time of the program are subject to change in case of unavoidable situations.

#### 1.1 <u>CONDUCT</u>

- 1.1.1 Students have to follow all the rules & regulations of PDPU during the workshop either on the campus or off the campus.
- 1.1.2 Alleged misconduct and violations of University policies and practices will be forwarded to the University's Disciplinary Committee for necessary actions.
- 1.1.3 Students must carry their I-cards with them during all workshops and out-station tours.
- 1.1.4 If a student has any concerns regarding the resource person or his/her team, he/she should convey it to the Project officer/PDPU faculty/staff present during the workshop/trip, rather than react or address the situation on his/her own. In case he/she fails to do so then the responsibility will lie on the individual concerned.
- 1.1.5 Resource person will be the authority during the workshop and students will have to follow the instruction given by the resource person for the effective execution of the workshop.
- 1.1.6 Student must submit a Questionnaire form (standard format for the same will be given from the school) for each activity they took part in.

- 1.1.7 During outdoor trips boys and girls will remain in separate quarters and behave decently and respectfully with each other in public and private spaces. They will strictly follow the instructions of the faculty and /or in charge official accompanying them.
- 1.1.8 Students are responsible to keep the working tables and surroundings clean after the completion of the workshop.
- 1.1.9 Students are require to bring/submit the art work as and when required by the Audit Course office

#### 1.2 <u>ATTENDANCE</u>

1.2.1 Students will have to reach to the workshop venue 10 min before the commencement of the workshop.

#### 1.3 <u>PENALTY</u>

- 1.3.1 If a student fails to reach to the class or the workshop venue on time (on the beginning and after the break), he/she will be considered absent and will have to pay fine of Rs. 1000/-
- 1.3.2 In case of unavoidable situation, student will have to take prior permission from the Program Coordinator to drop the program & he/she will have to attend the optional program to meet the requirement as directed by the Program Coordinator.
- 1.3.3 Any student who refrains to pay the penalty charges due on him/her, the degree certificate of the said student shall be withheld till the penalty charges are cleared.
